Feb. 24th at 2:00 p.m. – Forensics Fest – Please arrive at 1:30 p.m. for mingling and refreshments.

At 2:00 p.m., Beverly Hills Confidential Investigative reporter Barbara Schroeder and Beverly Hills Police Dept CSI Supervisor Clark Fogg, authors of Beverly Hills Confidential: A Century of Stars, Scandals and Murders, will re-examine the sensational and never-to-be-forgotten stories of the past century in Beverly Hills. Some examples include: the Doheny murder-suicide, gangster "Bugsy" Siegel's contract style murder, Charlie Chaplin's paternity trial, the death investigation of Lana Turner's boyfriend Johnny Stompanto, and the mystery surrounding the death of Jean Harlow's MGM mogul husband Paul Bern. Revisit the most horrific crimes: the heinous Menendez double homicide, the ill-fated Van-Cleef and Arpels attempted heist and triple homicide, and the recent, much publicized shooting of high-powered publicist Roni Chasen. Schroeder and Fogg will share their insight into how greed, jealousy, passion, corruption, and sometimes just simple bad luck, turned the onceidyllic movie star sanctuary into a haven for gruesome headlines.

At 3:00 p.m., we have another panel of talented, experienced investigators to enlighten our audience and answer questions, including:

Sam Zuorski - Sam worked for the Costa Mesa Police Department for 40 years, where he wore many hats; e.g. patrol duty, traffic enforcement, C.S.I. and field training. He worked in the detective bureau for 10 years; initially he worked Crimes against Children and then Crimes against Persons – including murders, robberies, sexual assaults & domestic violence. He retired in July 1997, but went back to work part time, where his primary assignment was to organize and work cold cases. Working cold cases involves reviewing the entire case – including every witness statement – conducting interviews, and evaluating all physical, biological and trace evidence.

Daniel McKerren – Daniel specializes in computer forensics and data recovery. He can answer questions regarding computer fraud, falsification of documents, and how to recover data that has been deleted from a computer. He will also address the topic of search warrants, probable cause, and how long it takes to obtain a warrant. (Hint: It's not quite as fast as it seems on T.V.)









The Forensics Fest got off to a great start last month with guest speakers, **Richard Longshore** and **Matt Weinstein**.

Richard Longshore worked for many years in the Los Angeles County Sheriff's Dept., first as a uniformed officer and later as a detective. On the same day he retired, he was rehired and assigned to investigate cold cases. He has been involved in over 300 death investigations, and he put to rest several murder myths and misconceptions. For example:

- There is no golden time period after which a murder cannot be solved.
- Confessions do not always lead to convictions.
- Polygraphs, while not admissible in court, can enable investigators to obtain a search warrant.
- Fingerprints on a weapon are not necessarily a slam dunk.
- Eyewitness testimony is not generally reliable.
- DNA is not always conclusive.
- Miranda rights must only be read once a suspect is in custody and being interrogated.
- Offering a reward for information in a case seldom works.
- Involving the public in an investigation brings out more false sightings than helpful information.
- Not every case involves physical evidence.

Richard took us through a fascinating cold case, the homicide of two El Segundo police officers in 1957, which only came to light because of a false confession from a dying man. A series of twists and turns, including a man digging up the murder weapon and stolen goods in his backyard and advances in technology which allowed investigators to combine two partial fingerprints into one, led to a conviction over 40 years later. The criminal is now behind bars and eligible for parole when he turns 90.

Matt Weinstein is a jack-of-all-trades when it comes to police work. He's worked on cases involving domestic violence, sex crimes, crimes against children, elder abuse, fraud, forgery, identity theft, robberies, and assaults. He is currently working for the Professional Standards Unit (PSU) investigating internal affairs, political corruption, officer involved crimes, etc.

Matt talked about identity theft and how little time it takes for a person to find a likely victim and establish a connection online. He discussed the CSI myth, noting that the job often involves dirty, painstaking work with little glamour or glory. And CSI personnel do not arrest criminals. He also told us how hard it is to get fingerprints off a gun, but that you can sometimes get good prints off the most unlikely objects.

Both men fielded questions from attendees and provided us with a unique look into the world of law enforcement and homicide investigation.
